- Tables **cannot** be transferred or sublet to other exhibitors. SPLIT Tables are allowed.
- All federal, state, and local laws are the table holders' responsibility to obey.
- As a courtesy to the public, we require exhibitors to stay for the duration of the show. Exhibitors leaving early will be invited NOT to return or at the very least sent to the end of the table waiting list and severely scolded.
- Exhibitors agree to hold the Copper State Cutlery Association and its officers harmless for any loss or damage of exhibited items or personal property. We encourage exhibitors to observe normal precautions. Security will be provided for Friday and Saturday night.
- Table will not be released to the exhibitor until CSCA receives a signed copy of these show rules.
- Fees are **non-refundable**. Approved extenuating circumstances will hold your monies for the next future show date.
- Exhibitors release to show sponsor full rights to use Exhibitor's name and/or business name in any form that the CSCS, its officers, and show promoter deem fit and will hold the CSCA, its officers, and show promoter harmless from use thereof.
- Smoking only in provided designated areas.
